

ソフトウェア使用許諾契約書

株式会社日立製作所（以下「当社」といいます。）は、ダウンロード又はその他の手段により提供され、インストールされた別紙 1「対象製品一覧」記載のソフトウェア（以下「本ソフトウェア」といいます。）について、後記「ソフトウェアのご使用条件」により使用を許諾します。

なお、本ソフトウェアの一部には、別紙 1 に記載のとおり、第三者ソフトウェアが含まれています。お客様は、本ソフトウェア使用許諾契約書記載のソフトウェアのご使用条件に加え、第三者ソフトウェアに適用される使用許諾条件（別紙に記載）のうち、お客様が使用する本ソフトウェアに適用される使用許諾条件をすべて必ずお読みの上、当該ご使用条件をご承諾ください。

ソフトウェアのご使用条件

お客様(以下「甲」といいます。)と株式会社 日立製作所(以下「乙」といいます。)とは、1.1項所定の許諾ソフトウェアに関し、次のとおり合意します。

1 定義

- 1.1 「許諾ソフトウェア」とは、本ソフトウェア・プロダクトに含まれる以下のオブジェクト・コード形式のコンピュータ・プログラムをいいます。

許諾ソフトウェア名: WebSAM iStorageManager Suite Ver9.3 - M100シリーズ

- 1.2 「CPU」とは、中央処理装置(Central Processing Unit)をいい、同一のコンピュータ内にある複数の中央処理装置の集合を含むものとしします。

2 使用権

- 2.1 乙は甲に対し、本「ソフトウェア使用許諾契約書」に基づきインストールしたコンピュータに係るCPU上でのみ、許諾ソフトウェアに関する、甲の内部作業目的のために使用する一身専属的、譲渡不能の非独占的権利を許諾します。
- 2.2 許諾ソフトウェアには本使用条件以外のライセンス契約に基づきお客様に使用許諾される部分が含まれることがあります。この場合、かかる部分に関してのご使用条件は、当該ライセンス契約の条件が本使用条件よりも優先します。

3 複製権

- 3.1 甲は、2.1 項所定の当該CPU上で許諾ソフトウェアを使用するために必要な場合を除き、許諾ソフトウェアを複製してはなりません。ただし、2.2項に記すライセンス契約に基づき使用許諾された部分については、この限りではありません。
- 3.2 甲は、本項に基づき許諾ソフトウェアを複製した場合には、当該許諾ソフトウェアに付された著作権表示その他の表示を再製し、これを当該複製物に付すものとしします。

4 移転等

- 4.1 甲は、乙の文書による事前の承認を得ることなく、許諾ソフトウェアを第三者に譲渡その他移転してはなりません。
- 4.2 甲は、乙の文書による事前の承認ならびに、日本国政府および関連する外国政府の必要な許可を得ることなく、直接または間接に、いかなる形式であっても、許諾ソフトウェアまたはその複製物を輸出、再輸出、転売、出荷もしくは転用させてはなりません。

5 逆コンパイル等

- 5.1 甲は、許諾ソフトウェアを改変、リバース・エンジニアリング、逆コンパイルまたは逆アセンブルしてはなりません。ただし、2.2 項に記すライセンス契約に基づき使用許諾された部分については、この限りではありません。
- 5.2 甲は、許諾ソフトウェア上または、その内部にある著作権表示その他の表示を除去または変更してはなりません。

6 無体財産権

- 6.1 本契約は、許諾ソフトウェアに関する無体財産権を甲に移転するものではありません。

7 無保証等

- 7.1 乙は、商品性(Merchantability)および特定目的との合致性(Fitness for any particular purpose) に関する保証ならびに第三者の権利を侵害しないことの保証を含め、許諾ソフトウェアに関していかなる保証も行いません。
- 7.2 前項の規定にかかわらず、許諾ソフトウェアが格納された媒体に欠陥(ただし、許諾ソフトウェアの使用に支障を来すものに限ります。)があった場合において、甲が、本ソフトウェア・プロダクトの提供を受けた日から14日以内に、かかる提供日を証明する受領書の写しおよび当該媒体を添えて文書により当該欠陥を乙に申し出たときは、乙は、当該欠陥を自己の責によるものと認めた場合に限り当該媒体を無償で取り替えるものとし、これをもって媒体に関する乙の一切の責任とします。
- 7.3 乙は、いかなる場合も、甲の逸失利益、特別な事情から生じた損害(損害発生につき乙が予見し、または予見し得た場合を含みます。)および第三者から甲に対してなされた損害賠償等の請求に基づく損害について一切責任を負いません。また、乙が損害賠償責任を負う場合には、乙の損害賠償責任は、その法律上の構成の如何を問わず、甲が実際に支払った本ソフトウェア・プロダクトの代金相当額をもってその上限とします。

8 期間

- 8.1 本契約は、甲が本ソフトウェア・プロダクトの梱包を解いた時に発効します。
- 8.2 甲が本契約のいずれかの条項に違反したときは、乙は本契約を解除し、本契約に基づき甲に許諾した権利を直ちに終了させることができます。この場合において、甲は、すべての許諾ソフトウェアおよびその複製物を直ちに破壊し、その旨を証する文書をかか終了後2週間以内に乙に提出するものとしします。
- 8.3 甲は、乙に対し文書により通知することにより、本契約を解除し、本契約に基づき甲に許諾された権利を任意に終了させることができます。この場合において、甲は、すべての許諾ソフトウェアおよびその複製物を事前に破壊し、その旨を証する文書を当該終了通知に添えて乙に提出するものとしします。

9 その他

- 9.1 乙は甲に対し、本契約に明示的に定めるところを除き、何らの権利も付与するものではありません。
- 9.2 甲がアメリカ合衆国政府関連機関の場合の権利の取り扱いは、次の各号のとおりとします。
- (1)Federal Acquisition Regulations (連邦調達規則) 252.227.-7013 (当該条項の改正法を含む) に定められる技術情報およびコンピュータソフトウェア条項におけるアメリカ合衆国政府関連機関の権利規定が適用されます。
- (2)甲が国防省関連機関の場合、Restricted Rights Regulations (権利制限規則) が適用されます。
- (3)甲が国防総省以外のアメリカ合衆国政府関連機関の場合、Restricted Rights Regulations (権利制限規則) と同等の規定が適用されます。
- 9.3 本契約にかかわる紛争は、東京地方裁判所を第一審の専属的合意管轄裁判所として解決するものとしします。
- 9.4 甲が、本ソフトウェア製品に関する保守またはサポートを、乙から別途契約等に基づき受けることを選択された場合は、当該保守またはサポートの有償サービス開始時期は、本ソフトウェア製品が甲に納品された日を含む月の翌月1日とします。
